Day Use Reminders

Summer is fast approaching and we'd like to take a moment to remind you of our Day Use policy.

- All Owners must sign at the Activities Desk before using the facilities on Day Use.
- At the time of sign in, you must be prepared to show photo



identification.

- Benefits are limited to the Grant Deed Owner and immediate family, defined as spouse, children, grandchildren, and/or parents.
- Day Use is not to exceed the number of people established as maximum occupancy for the unit owned.
- Non-immediate family members (guests) may utilize Day Use if an adult Owner (or adult immediate family member) is present.
- Underage (under 21) children of an owner must have adult supervision during any Day Use.



Summer Day Use Parking is extremely limited; please use the free parking around the resort or the free city parking within a few blocks of the resort when enjoying your day use benefit. We will try to accommodate Day Use parking as space becomes available. If parking is available in the garage, you will be issued a parking permit to place on your dashboard.

We encourage you to take advantage of your Day Use benefits. We are making every effort to eliminate the unauthorized visits by locals so we ask for your support and take just a couple of extra minutes to sign in! We will be continuing our wrist band program during Spring Break and the busy summer months again this year. Your cooperation in wearing your wrist band while at the Carlsbad Inn is greatly appreciated. Our goal is to ensure that all Owners and Guests have an enjoyable time during their stay and it is our responsibility to make sure that the amenities are available for you to use.
